

**DIRECTIONS:**

- Highest dilution ratios should be used when washing in the sun or extremely hot surfaces.
- Clear-Cut can be diluted up to 1 to 50 and still cut grease for light household cleaning.
- **AUTOMOTIVE INDUSTRY USE:**  
Depending on type of equipment used, dilution and contact time may vary.
- **HOT HIGH PRESSURE:**  
*Light cleaning:* 1 to 20 parts water *Heavy cleaning:* 1 to 10 parts water
- **GENERAL CLEANING:** (floors, walls, etc.)  
1 to 30 parts water
- **HEAVY GREASE WITHOUT PRESSURE:** 1 to 5 parts water
